Door to Door Solicitor Instructions

<u>Important</u>: It is the responsibility of the employer to insure the information of the applicant is accurate and up to date. If an applicant is denied because of false or inaccurate information provided on the application, the employer (or any of its representatives) may be denied permission to solicit in The City of Melrose

- 1) Each person must fill out an application
- 2) Each applicant must submit the completed application in person with a picture ID.
- 3) The application will be processed (usually within 72 hours) and the applicant will be contacted and informed if the application was **approved** or **denied**.
- 4) If **denied** you cannot solicit in the City of Melrose.
- 5) If **approved** each solicitor must
 - Check in (<u>in person</u>) at the Melrose Police Dept. and inform the desk officer of the locations you will be canvasing, hours you will be in the area and any vehicle you will be using.
